A motion was made by Commissioner Shumate, duly seconded by Commissioner Sims, and all members voting affirmatively and so carried to approve the consent agenda presented as read by Chairman Hutcheson. A motion was made by Commissioner Sims, duly seconded by Commissioner Watson and all members voting affirmatively and so carried to approve PE & Construction Funding Agreement and Resolution with ALDOT for intersection improvements of Oneonta Cut-off Road, Turnpike Road and SR205 Project ATRP2-48-20024-048.

RESOLUTION

Which agreement is before this Commission, and that the agreement be executed in the name of the County, by the Chairman for and on its behalf and that it be attested by the County Clerk and the official seal of the County be affixed thereto.

BE IT FURTHER RESOLVED, that upon the completion of the execution of the agreement by all parties, that a copy of such agreement be kept on file by the County.

ENGINEERING- APPROVE TO CHANGE THE SPEED LIMIT FROM 45 TO 55 MPH ON THE LAST 1.2 MILES TO THE JACKSON COUNTY LINE OF CATHEDRAL CAVERNS HWY.

A motion was made by Commissioner Watson, duly seconded by Commissioner Sims and all members voting affirmatively and so carried to approve to change the speed limit from 45 to 55 MPH on the last 1.2 miles to the Jackson County Line of Cathedral Caverns HWY.

ENGINEERING- APPROVE SPEED LIMIT ON GENE BROWN ROAD IN DISTRICT 3 FOR A REGULATORY SPEED OF 25 MPH FROM BROWN ROAD TO ETOWAH COUNTY LINE.

A motion was made by Commissioner Sims, duly seconded by Commissioner Baker and all members voting affirmatively and so carried to approve a 25-mph regulatory speed limit on Gene Brown Road in District 3 from Brown Road to Etowah County Line.

<u>DATA PROCESSING- APPROVE TO PURCHASE BACKUP SOFTWARE AND DATA CLOUD STORAGE;</u> \$3,305.70 GENERAL FUND BALANCE.

A motion was made by Commissioner Watson, duly seconded by Commissioner Shumate and all members voting affirmatively and so carried to approve to purchase backup Software and Data Cloud storage from Gov Connection for \$3,305.70 from General Fund Balance.

APPROVE PURCHASE AGREEMENT WITH HARRIS FOR SOFTWARE SERVICE; \$13,300.00 GENERAL FUND, FUND BALANCE.

A motion was made by Commissioner Sims, duly seconded by Commissioner Baker and all members voting affirmatively and so carried to approve a purchase agreement with Harris for software service; \$13,300.00 from General Fund, Fund balance.

SHERIFF- APPROVE ENTERING INTO PAYMENT AGREEMENT WITH CARDIAC SOLUTIONS TO PURCHASE A TOTAL OF 51 AED'S OVER THE COURSE OF 4 YEARS WITH THE LAST YEAR'S FINAL PAYMENT TO BE \$134,999.98 TO BE PAID BY THE COUNTY'S GENERAL FUND. THE FIRST 3 PAYMENTS OF \$30,000.00 EACH WILL BE PAID BY THE SHERIFF'S DISCRETIONARY FUNDS.

A motion was made by Commissioner Shumate, duly seconded by Commissioner Sims and all members voting affirmatively and so carried to approve entering into a payment agreement with Cardiac Solutions to purchase a total of 51 AED'S over the course of 4 years with the last year's final payment to be \$134,999.98

to be paid by the County's General Fund, fund balance. The first three payments of \$30,000.00 each will be paid by the Sheriff's Discretionary Funds. The AED's will be for Patrol Vehicles and SRO officers.

SHERIFF- APPROVE INCREASING BUDGET BY \$18,624.00 FOR RADIOS THAT WERE ORIGINALLY ANTICIPATED TO BE PAID IN FY2023 BUT NOT INVOICED UNTIL CURRENT YEAR, TO BE PAID BY GENERAL FUND, FUND BALANCE. THIS WAS ORIGINALLY APPROVED ON 07/26/2023.

A motion was made by Commissioner Shumate, duly seconded by Commissioner Sims and all members voting affirmatively and so carried to approve to increase the budget by \$18,624.00 for Radios that were originally anticipated to be paid in FY23 but not invoiced until the current year. To be paid by General Fund, Fund Balance.

CORONER- APPROVE 36-MONTH SERVICE CONTRACT WITH TRI HAZ SOLUTIONS TO PICK UP AND DISPOSE OF ANY MEDICAL WASTE; \$540 YEARLY FROM BUDGET.

A motion was made by Commissioner Sims, duly seconded by Commissioner Shumate and all members voting affirmatively and so carried to approve a 36-month service contract with Tri Haz Solutions to pick up and dispose of any medical waste; \$540.00 yearly from the budget.
