A motion was made by Commissioner Sims, duly seconded by Commissioner Shumate, and all members voting affirmatively and so carried to approve to purchase supplies for new animal control building in the amount of \$47,042.00 to be paid out of general fund fund balance.

CORONER – APPROVE PURCHASE OF DESKS, CONFERENCE TABLES, BOOKSHELVES, AND OFFICE CHAIRS FROM AMAZON IN THE AMOUNT OF \$12,792.68 TO BE PAID FROM ARPA REVENUE REPLACEMENT FUNDS

A motion was made by Commissioner Sims, duly seconded by Commissioner Watson, and all members voting affirmatively and so carried to approve purchase of desks, conference tables, bookshelves, and office chairs from Amazon in the amount of \$12,792.68 to be paid from ARPA revenue replacement funds.
