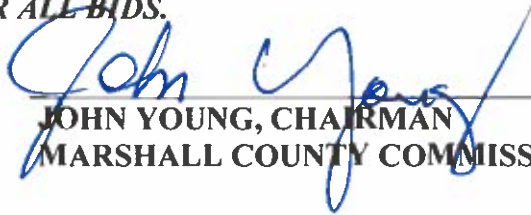
SPECIAL INSTRUCTIONS TO BIDDERS:

- (2) Vendor is required to submit brochures showing vehicle and emergency equipment package bid, and also include a summary of warranty coverage for the model(s) and emergency equipment package being bid.
- (3) All equipment is to be factory installed unless otherwise indicated and/or authorized. All title fees as well as other charges are to be paid by vendor. Warranty card and service policy must accompany truck(s) when delivered. Vendor is to furnish prepaid certificate of title(s) to the Marshall County Commission.
- (4) Contained in the bid specifications, you will note that brand names have been specified. This is in no way an attempt to restrict bidding but is an attempt to assure that items purchase will be of equal quality or better.
- (5) Bid may be submitted whether by mail or in person, however, Marshall County will not be responsible for the security of mailed bids. (Also, if mailing bid, please be advised that we do not receive mail before 10:00 A.M. daily; therefore, mail early to ensure prompt arrival.)
- (6) By signing and submitting of this bid, the vendor certifies that he/she is an equal opportunity employer.
- (7) It shall be the bidder's responsibility to possess all proper County, State, and Federal license, and shall familiarize himself with and shall comply with all Federal, State, and local laws, ordinances, and regulations.
