(4) Contained in the bid specifications, you will note that brand names have been specified. This is in no way an attempt to restrict bidding but is an attempt to assure that items purchase will be of equal quality or better.

(5) This bid shall be good for the period beginning March 11, 2026, and going through December 31, 2026.

(6) Bid may be submitted whether by mail or in person, however, Marshall County will not be responsible for the security of mailed bids. (Also, if mailing bid, please be advised that we do not receive mail before 10:00 A.M. daily; therefore, mail early to ensure prompt arrival.)

(7) By signing and submitting of this bid, the vendor certifies that he/she is an equal opportunity employer.

(8) It shall be the bidder's responsibility to possess all proper County, State, and Federal license, and shall familiarize himself with and shall comply with all Federal, State, and local laws, ordinances, and regulations.

(9) Bidders **are required** to use this "*Invitation for Bids*". Failure to do so will be cause for rejection of bid.

(10) Bidders shall bid all items, sign, and return all sheets in the "*Invitation for Bids*" to **Marshall County Engineering Department, 424 Blount Ave., Suite 305, Guntersville, AL 35976.**

(11) Please be advised that in the event a bid is received from a person, firm, or corporation deemed to be a responsible bidder, having a place of business within Marshall County, AL, and the bid is no more than five (5) percent greater than the bid of the lowest responsible bidder, the Marshall County Commission may award the bid to the resident responsible bidder.

(12) By signing this contract the contracting parties affirm, for the duration of the agreement that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom.
