- (1) A bid bond in the amount of \$500.00 shall be included with each bid submitted.
- (2) A performance bond in the amount of \$5,000.00 will be required within seven (7) working days of the date of the notice of award.
- (3) The successful bidder is expected to have all bid items in stock as no backorders will be accepted.
- (4) Date of delivery shall be immediately upon placement of order. When billing, the invoice number and purchase order number <u>must</u> appear on each invoice.
- (5) Price shall include delivery charges to the jail location in Guntersville, Alabama.
- (6) Contained in the bid specifications, you will note that brand names have been specified. This is in no way an attempt to restrict bidding but is an attempt to assure that items purchased will be of equal quality or better.
- (7) The successful bidder, for the above-named items, shall keep an up-to-date running total (dollar amount) of all items purchased. Each item shall be listed individually and the quantity purchased plus the dollar amount shall be available upon request by the Marshall County Commission or an authorized representative thereof.
- (8) The Marshall County Commission reserves the right to award this contract as a whole or in part, whichever is in the best interest of Marshall County.
- (9) This bid shall be good for the period beginning October 1, 2025 and going through September 30, 2026. An option to issue a second and third 12-month contract with the same pricing, terms and conditions is possible. The second or third contract, if agreed by both parties, would begin the day after the first or second contract expires. Any successive contract must have the written approval by the County and the vendor.
- (10)Bids may be submitted either by mail or in person, however, Marshall County will not be responsible for the security of mailed bids. (Also, if mailing bid, please be advised that we do not receive mail before 10:00 A.M. daily, therefore mail early to ensure prompt arrival).
- (11) By signing and submitting of this bid, the vendor certifies that he/she is an equal opportunity employer.
- (12) Bidders <u>are required</u> to use this "Invitation for Bids." Failure to do so will be cause for rejection of bid.
- (13) Bidders shall sign, and return <u>all</u> sheets in the "Invitation for Bids" to <u>Marshall County</u> <u>Engineering Department, 424 Blount Avenue, Suite 305, Guntersville, AL 35976</u>. Failure to do so will be cause for rejection of bid.

- (14) Each individual bid must be submitted in a sealed envelope with the word "BID" and name of item marked on outside of envelope.
- (15) Please be advised that in the event a bid is received from a person, firm, or corporation deemed to be a responsible bidder, having a place of business within Marshall County, AL, and the bid is no more than five percent (5%) greater than the bid of the lowest responsible bidder, the Marshall County Commission may award the contract to the resident responsible bidder.
- (16)By signing this contract the contracting parties affirm, for the duration of the agreement that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom.

Each bidder is required to submit with the bid a certificate of E-Verify.

You are invited to bid on the above specifications. Any substitutes offered, other than the items specified, must include information showing that the substitute is of equal or better quality and equally or better suited for the purported use than the item specified. The right to reject any items or materials not of quality or under any provisions of this act is reserved.
