- (3) It is the Bidder's responsibility to familiarize himself with and shall comply with all requirements and specifications as stated in the <u>Alabama Department of Transportation Standard Specifications for Highway Construction-2018 Edition.</u> The definition for "State" as listed in the before mentioned manual, in Section 101.01, shall be changed to read as follows: "Marshall County, a political subdivision of the State of Alabama, the party of the first part to the contract acting by and through the Marshall County Engineer".
- (4) Vendor shall include in his/her bid prices for the before specified items, delivery charges to the location in Marshall County, Alabama desired by the Marshall County Commission or their authorized representative.
